The 2020 Kennel Lake membership dues are due and must be **postmarked** no later than January 31, 2020. The renewal fee for 2020 is \$150.00 unless you have volunteered at the Club during this past year. If you have volunteered your time in 2019, please locate your dues amount on the top right-hand corner of the renewal form (opposite side).

To pay your 2020 dues, simply complete the form on the other side and mail it with your individual dues and boat slip fees to Kennel Lake Sportsmen's Club, P. O. Box 288, Morton, IL 61550. Please complete ALL information to ensure that our records are accurate and up to date. We have retained the provision for 2020 to allow a 19-year-old whose family is a Club member to join the Club without paying an initiation fee. A member of affiliate members shall apply in person for an extension of affiliate membership on a year-by-year basis until 25 years of age, pending Board approval. Child must be between the ages of 18-24, in school and still has same address as member. See a Board member or contact the Secretary for more information.

### **\*\*FRIENDLY REMINDER - PLEASE READ CAREFULLY\*\***

**As per county and state regulations: alcohol, tobacco, glass or cans are prohibited in the water and beach area. Please drink responsibly. Violation of Club rules:** Any member may be fined fifty dollars (\$50) per offense for violating any rule of the Club. Fine is payable within thirty (30) days from the notification by the Board. To obtain a Kennel Lake handicap parking permit, you must appear in person at a monthly Board meeting to request a Kennel Lake handicap permit. Permits will expire at the end of every year. Previously issued permits will no longer be accepted!

**Boat Slip Rental:** There is a fee of \$60.00 to keep your boat at the lake year-round. Your boat must be secured to a cable provided by the lake. From time to time, boats will need moved to maintain the area. This payment is due at the same time as your membership dues (January 31, 2020). **WARNING: If fees are not paid by January 31<sup>st</sup>, boats slips will be made available to the members on the waiting list.**

**Clubhouse Rental:** The Clubhouse Rental fees for members are as follows: Small room \$100, Large Room \$150, Both rooms \$225. Plus \$100 refundable clean up deposit. To make a reservation, call 266-9641.

**Late Payment Fines:** A fine of 10% (\$15) per month will be assessed for late fees. To avoid this fee, dues must be mailed in and **postmarked** by January 31, 2020.

**Violation of club rules:** Any member may be fined fifty dollars (\$50) per offense for violating any rule of the club. Fine is payable within thirty (30) days from the notification of the Board.
